- Space is not reserved until a signed agreement and \$100 deposit is received, and the space is not confirmed until final payment and insurance paperwork is received. All deposits are non-refundable.

HOURS OF OPERATION: All booths must remain open during hours of event operation. Detailed setup instructions for July 22 will be provided at least one week before the event.

INSURANCE: No vendors will be permitted to participate without proof of insurance with a minimum of \$1,000,000 valid through the event dates, with the description of operations as "Butler Bikes & BBQ", event dates July 22-25, 2021. Please attach insurance certificates naming the following as additionally insured:

HEALTH CARD CERTIFICATIONS: Vendors will not be permitted to sell food without proper health department certifications. Those certifications should be mailed with your other paperwork.

MERCHANDISE RESTRICTIONS: Butler County Tourism & Convention Bureau has the exclusive right to display, license, sell and merchandise all "Butler Bike & BBQ" event novelties (t-shirts, collectibles, etc.). Butler County Tourism & Convention Bureau and Appleseed Events LLC further have the right to inspect, approve, reject or otherwise control the display, promotion, sale or other merchandising of products or services by exhibitors at the event in its sole discretion. Any product or service rejected by Butler County Tourism & Convention Bureau or Appleseed Events LLC must be immediately removed from the event premises and may be removed by security or event planner if vendor fails to comply with the request for their removal. Illegal drugs and/or drug paraphernalia, weapons, merchandise containing racial slurs, obscenities or other offensive or other detrimental matter, manufacturer or copyright infringements, will not be permitted. Merchandise designed to be passed off and considered as "Butler Bikes & BBQ" (use of city, date, event name, trademarks, etc.) or which has this effect will also not be permitted. The selling vendor will be removed from event property and there will be no refund of vendor fees.

RELEASE OF LIABILITY: Applicants agree to observe and comply with all applicable laws, statutes, ordinances, rules and regulations. Applicant assumes all cost and liability arising from the use of patented, trademarked, copyrighted or service marked materials, equipment, processes or creative rights. Applicants shall now assign or attempt to sell or assign this agreement or any rights hereunder without the prior written consent of Butler County Tourism & Convention Bureau or Appleseed Events LLC. Butler County Tourism & Convention Bureau and Appleseed Events LLC reserves the right to terminate the license granted by this agreement for good cause and, in said event, Applicant agrees to waive and forego all claims for damages and recourse of any kind. Applicant agrees to assume all risks arising out of or relating to is attendance or participation at said event and to protect, defend, indemnify and hold harmless Butler County Tourism & Convention Bureau, Appleseed Events LLC, and Butler Farm Show Grounds, the owner and operator of the event site and facility, and each of their agents, servants, contractors and employees from any and all liability, loss, damage or expense it may cause or sustain from any cause whatsoever, including fire, theft, personal injury or property loss. I further acknowledge that I am aware that I cannot sell, give or offer for sale any pictures of accounting of this event for publication without the written consent and permission of Butler County Tourism & Convention Bureau and Appleseed Events LLC.
